CERTIFICATION OF LAW ENFORCEMENT RETIREMENT-LEOSA

I, _____, (please print) am applying for a license to carry a concealed firearm pursuant to KRS 237.138- 237.142 and the Law Enforcement Officers Safety Act of 2004 (LEOSA), 18 U.S.C. 926C, Public Law 108-277 and hereby certify, as evidenced by my signature below, that:

1) I retired in good standing from service with _____ (Agency name) as a law enforcement officer, other than for reasons of mental instability;

2) Before such retirement, I was authorized by law to engage in or supervise the prevention, detection, investigation, or prosecution of, or the incarceration of any person for, any violation of law, and had statutory powers of arrest;

3) Before such retirement, I was regularly employed as a law enforcement officer for an aggregate of 15 years or more or retired from service with such agency, after completing any applicable probationary period of such service, due to a service-connected disability, as determined by such agency;

4) I have a nonforfeitable right to benefits under the retirement plan of the above named agency;

5) During the most recent 12-month period, I have met, at my expense, the standards of the Commonwealth of Kentucky for training and qualification for active law enforcement officers to carry firearms;

6) I am not under the influence of alcohol or another intoxicating or hallucinatory drug or substance;

7) I am not prohibited by state or federal law from possessing or receiving a firearm;

8) I understand that my license to carry a firearm pursuant to LEOSA is valid for a period of one (1) year from the date of my last range qualification and will expire on the date indicated on my license. I also understand that a LEOSA license is not automatically renewable and that I must re-apply for a license if I wish to continue to carry a concealed firearm pursuant to LEOSA after the expiration of the initial one (1) year period; and

9) I have read and am familiar with the provisions of KRS 237.138-237.142 and LEOSA, as set forth in 18 U.S.C. 926C, Public Law 108-277.
